Enforcement actions of temporary prohibition of people gathering at sport events, operation of conference rooms and Open Care Centres for the Elderly (K.A.P.I.).

THE MINISTERS

OF DEVELOPMENT AND INVESTMENTS - CITIZEN PROTECTION - HEALTH -CULTURE AND SPORTS - INTERIOR

Having regard to:

1. The provisions of the first article of the Legislative Decree of the 25.02.2020 " Urgent Measures for Avoidance and Restriction of Spreading Coronavirus (COVID-19)" (A' 42) and especially the case 7 of paragraph 2 and paragraph 4.
2. The Presidential Decree under number 174/2017 "Organization of the Ministry of Economy and Development" (A' 192), as applicable.
3. The Presidential Decree under number 86/2018 "Reconstitution of the Ministry of Public Order and Citizen Protection which was renamed to Ministry of Citizen Protection" (A' 159),as applicable.
4. The Presidential Decree under number 121/2017 "Organization of the Ministry of Health" (A' 148), as applicable.
5. The Presidential Decree under number 4/2018 "Organization of the Ministry of Culture and Sports" (A' 7), as applicable.
6. The Presidential Decree under number 141/2017 "Organization of the Ministry of Interior" (A' 180), as applicable.
7. The Presidential Decree under number 83/2019 "Appointment of a deputy Prime Minister, Ministers, deputy or assistant Ministers » (A' 121).

8. The Prime-Minister's and Ministers of Culture and Sports joint decision under number ΥΠΠΟΑ/ΓΡΥΠ/410721/8291/29.07.2019 "Delegation of powers to the Deputy Minister of Culture and Sports Mr. Eleftherios Avgenakis" (B' 3099).

9. The recommendation of the National Public Health Protection Committee against the coronavirus COVID-19 dated on 07.03.2020.

10. The certificate of the Directorate for Budget and Financial Reports under number B1a/official 15950/ 08.03.2020, according to which the issue of the present decision entails no expenditure under the national budget, we decide:

Article 1

The temporary prohibition of people gathering at sport events, which take place throughout the country, in indoor and outdoor areas from 09.03.2020 until 22.3.2020, for precautionary reasons of public health as referred in the recommendation of the National Public Health Protection Committee against the coronavirus COVID-19 dated on 7th March 2020.

Article 2

The temporary prohibition of operation of conference events throughout the country from 09.03.2020 until 05.04.2020, for precautionary reasons of public health as referred in the recommendation of the National Public Health Protection Committee against the coronavirus COVID-19 dated on 7th March 2020.

Article 3

The temporary prohibition of operation of Open Care Centres for the Elderly (K.A.P.I.), throughout the country from 09.03.2020 until 05.04.2020, for precautionary reasons of public health as referred in the recommendation of the National Public Health Protection Committee against the coronavirus COVID-19 dated on 7th March 2020.

National Printing House

The National Printing House is a public service subject to the Presidency of the Government, responsible for the draft, administration, printing and distributing of the Official Journal of the Hellenic Republic (*ΦΕΚ*), as well for covering the printing and publishing requirements of the public and wider public sector (Greek Law number 3469/2006/A' 131 and Presidential Decree number 29/2018/A' 58).

1. OFFICIAL JOURNAL OF THE HELLENIC REPUBLIC (*ΦΕΚ*)

- The website of the National Printing House www.et.gr provides free access to the **Official Journal of the Hellenic Republic (*ΦΕΚ*) in electronic form**. Those official Journals of the Hellenic Republic (*ΦΕΚ*), which haven't been digitized and registered in the aforementioned website, are digitized and send also for free by the lodging of a request, for which the completing of the necessary information in the special form in the website www.et.gr is sufficient.

- **Official Journal of the Hellenic Republic (*ΦΕΚ*) in paper format** is available in individual sheets whether directly from the Sales and Subscribers Department whether by post office by placing an order at the Citizens Service Center (*ΚΕΠ*), whether by an annual subscription through the Sales and Subscribers Department.

The costs of a black and white Official Journal of the Hellenic Republic (*ΦΕΚ*) from 1 to 16 pages is 1.00 € and for any additional eight-pages (or part of it) the price shall be increased by 0.20 €. The costs for a color Official Journal of the Hellenic Republic (*ΦΕΚ*) from 1 to 16 pages is 1.50 € and for any additional eight-pages (or part of it) the price shall be increased by 0.30 €. The ASEP (Supreme Council for Personnel Selection) announcements are provided for free.

- **Shipping of texts for publication:**

A. Texts for publication in the Official Journal of the Hellenic Republic (*ΦΕΚ*) by authorities and public sector entities are send electronically at the address webmaster.et@et.gr by using advanced digital signature and time stamp.

B. Exceptionally, those citizens who do not have advanced digital signature may send their texts printed on paper in order to be published by post or submit them through a representative at the Department of reception and registration of publications.

- Information regarding mailing/ submitting documents in order to be published, the daily Official Journal of the Hellenic Republic (*ΦΕΚ*) circulation, the sale of the issues and the pricelists applicable of our services, is included in the website (www.et.gr). Furthermore, through the website information is given regarding the publication of documents based on the Publication Code Number (*ΚΑΔ*). This is the number issued by the National Printing House for all texts, which fulfill the publication requirements.

2. PRINTING AND PUBLISHING REQUIREMENTS OF THE PUBLIC SECTOR

The National Printing House responding to the requests of authorities and public sector entities undertakes the responsibility to draw and print forms, pamphlets, books, posters, notebooks, business forms, envelopes of any type, etc.

Furthermore, it draws digital publications, logos and it produces audiovisual material.
